

PERMIT FEE SCHEDULE

TRANSPORTATION PERMITS

OVER WIDTH/OVER HEIGHT/OVER LENGTH/OVER WEIGHT

Annual Cab Card	\$100.00
Single Move	\$ 25.00

Permits for Overweight vehicles will only be issued for loads that can be separated or reduced. Annual Cab Cards will only be issued for vehicles that do not exceed legal limits by more than twenty-five percent (25%). All other vehicles may be permitted on a single move basis.

MOBILE HOMES & MODULARS

Annual Cab Card (per truck)	\$100.00
Single Move	\$ 30.00

Annual Cab Cards will only be issued for Mobile Homes or Pre-built modules that do not exceed any of the following maximum dimensions: Width 14'; Height 13'6"; Length 80'. All others may be permitted on a single move basis.

An inspection fee may be required for these permits. The amount of the fee will be determined by the anticipated cost of the inspection for the permit.

HOMES & BUILDINGS

Single Move	\$30.00 with a \$1,000.00 Bond

Non-emergency Public Utility Work with Legal Axle Weights During Seasonal Weight Restrictions Single/Multiple Moves	\$100.00 Per Vehicle

NOTE: If the vehicle does not have a proper cab permit, the vehicle will not be allowed to proceed until proper permit is purchased and the amount of the fee will be doubled. All vehicles brought to the yard without proper permits will be charged a storage fee of \$10 per day. This will include the day brought to the yard and the day leaving the yard whether full days or not. (per Don Babcock 7/16/99)

DRIVEWAY PERMITS

All driveways must be surfaced (gravel or asphalt). See typical detail for standards. Commercial driveways shall be completed by a pre-qualified contractor or with financial assurance of \$10,000.00 acceptable to Crawford County Road Commission is required.

Contractor(s) and/or property owner(s) have performed, in accordance with the permit requirements, significant and acceptable work for at least one year may be pre-qualified by Crawford County Road Commission.

ANNUAL PERMITS

Maintenance/Tree Trimming	\$ 200.00

- Aerial Utility Facilities - Adding cable to existing poles.
- Underground Utility Facilities
 - Parallel Single Service only
 - Maximum permit required when:
 - Less than 28' offset from centerline.
 - Crossing an road (See Transverse Permits)
- Other activities may be allowed subject to Crawford County Board of Commissioners.

\$5,000.00 Bond and/or letter of credit and Certificate of Insurance may be required.

Any person or organization performing activities covered by an annual permit shall give advance notice to the Crawford County Road Commission before 8:00 am on the date of the scheduled activity.

MISCELLANEOUS

Citizen to work in Right of Way	\$30.00

Any other permit not falling under the afore-mentioned fee schedule will be reviewed on a case by case basis for fees, bonds and/or Insurance requirements.

Checks are to be made payable to Crawford County Road Commission.

All permit applications should be sent to Crawford County Road Commission with the appropriate attachments (i.e. vehicle information, proposed route, area sketch, Insurance, etc.).
